1. Wax sealed tenders should be submitted through Registered/Speed Post only on letter head of authorized firm. Tenders submitted by hand will not be accepted.
2. The tenders should reach the office of Assistant Registrar, Bhaderwah Campus by or before last date i.e. 28.10.2017. Tender received after last date will not be accepted.
3. Rates should be quoted F.O.R Bhaderwah Campus at Sungli and should be inclusive of all taxes/GST etc. if applicable.
4. Quantity can be increased/decreased as per requirement.
5. No conditional or over written tender will be accepted.
6. 5% cost of material will be kept as a deposit for a period of one year.
7. Any defective supply or not fulfilling the specification will be out rightly rejected and the supplier will have to replace it with proper specification of material.
8. Supply will have to be made within 15 days from the date of issue of supply order.
9. The rates quoted will be valid till the supply is made in full.
10. Tender opening Committee Bhaderwah Campus reserves all rights to accept or reject one or all tenders without assigning any reasons what so ever.
11. The tenderer must enclose the letter of authorized dealership, copies of TAN, VAT & PAN card.
